01 INTERIM PERFORMANCE REPORT FOR THE PERIOD JANUARY – JUNE 2025

Overview

We are hereby presenting our results for the first six months of 2025. The report presents the consolidated performance of Arena Hospitality Group d.d ('AHG' or the 'Company') and its subsidiaries (the 'Group') in all countries of operation including Croatia, Germany, Hungary, Serbia and Austria, and separate performance in Croatia.

We are pleased to report continued growth in demand during the first half of 2025, with stable performance recorded across all three of our operating regions—Croatia, Germany, and CEE.

The Group delivered a stable and encouraging performance in the first half of 2025, with total revenue rising by 4.4% year-on-year to EUR 52.5 million. This growth was driven by a 4.8% increase in accommodation revenue and a 12.5% improvement in EBITDA, reflecting the success of our strategic focus on premium offerings and operational efficiency. Our Croatian portfolio led the way, with a 7.7% revenue increase and record-breaking results in June, supported by strong ADR growth and the contribution of newly renovated campsites. The CEE region also performed well, achieving a 12.9% revenue increase and improved profitability across all markets. While the German portfolio faced headwinds due to fewer major events, we maintained cost discipline and preserved solid occupancy levels. Overall, these results affirm the resilience of our diversified portfolio and the effectiveness of our long-term investment strategy.

The Group benefits from liquidity, with its cash and short-term deposit position on 30th June 2025 at EUR 19.7 million and with no increases in interest associated with debt and no new refinancing activities, the Group's cashflow remains consistent with its current expectations considering changes in working capital requirements due to the seasonal nature of part of its business.

Highlights

- Total consolidated revenue to date of EUR 52.5 million, representing increase of 4.4% year-on-year indicating a continuation of gradual improvement. RevPAR of EUR 44.4 (14.1% increase versus last year).
- Although minimum wages rose by 5% to 15% and complied with across all three operating regions, the Group effectively and efficiently managed payroll expenses, keeping the overall increase to circa 2% year-over-year.
- In Croatia, a well-timed holiday schedule significantly contributed to an increase in ADR, resulting in a total revenue of EUR 32.1 million up 7.7% year-on-year.
- The absence of major sporting and trade fair events in Germany led to a decline in total revenue, driven by a decrease in ADR, despite occupancy levels remaining stable.
- Encouraging improvement in CEE region, as a result of newly renovated properties delivering 12.9% growth in revenues and 12% growth in occupancy. Consequently, RevPAR experienced growth to EUR 85.2.

Development

Repositioning projects of Arena Stupice and Arena Indije Campsites

Upgrades to the core facilities at Arena Stupice and Arena Indije campsites were completed in Q2 2025, following their initiation in late 2024. These upgrades aligned the campsites with recent major enhancements across the Group's portfolio and are intended to elevate them from two to four stars, providing premium camping experiences that support higher returns. The project included replacing all existing mobile homes with modern, spacious premium units, refurbishing sanitary blocks, enhancing landscaping, modernising pitches to premium standards, and improving recreational areas for children.

Arena Stupice Campsite facilities: Campsite, two restaurants, fast food outlet, grocery store, coffee shop, water sports and recreation centre, new kids' playground and open-air fitness.

Arena Indije Campsite facilities: Campsite, upscale mobile homes of 40 sqm, restaurant, bar, grocery store, diving school, new kids' playground and open-air fitness.

CURRENT TRADING AND OUTLOOK

Trading since 30 June 2025 is in line with our expectations across our three operating regions.

In Croatia we are in the middle of the summer season and are expecting continuation of the positive trends from the first six months. While we remain optimistic for the summer season based on the current demand levels and our booking pace, we are still seeing that consumers are making last-minute booking decisions which impacts our overall visibility for the season ahead.

In Germany, we expect to continue building our occupancy and average daily rates and continue to benefit from the planned international trade fairs and events in Berlin, Cologne and Nuremberg.

In our CEE region we will focus on delivering solid summer season in Nassfeld and driving the operational performance of our properties including Belgrade and Budapest.

Given the current economic climate the Group, plans to conserve and improve its liquidity, nevertheless remains committed to uplifting the campsite and hotel portfolio standard through regular investment projects, rebranding to maximise opportunity, prepare for investments throughout all the regions and explore new high potential growth opportunities in Croatia and Central and Eastern Europe.

Total revenue increased compared to prior year and amounted to EUR 52.5 million (2024: EUR 50.3 million). Accommodation revenue increased by 4.8% to EUR 41.4 million (2024: EUR 39.5 million), whereby occupancy increased by 350.7 bps to 42.0% and the average daily rate increased by 4.5% to EUR 105.7 (2024: EUR 101.1).

EBITDA profit increased by 12.5% and amounted to EUR 3.6 million (2024: profit EUR 3.2 million) and was year-on-year positively influenced mostly by increase in revenues and ADR.

Moreover, the Group is focussed on preserving its sustainability by further optimising its costs. The Group's cash and short-term deposit position amounted EUR 19.7 million.

For this region, total revenues increased by 7.7% to EUR 32.1 million (2024: EUR 29.8 million) and accommodation revenue increased by 10.1%. At the same time, average daily rate increased by 12.5% and amounted to EUR 93.8 (2024: EUR 83.4) as well as occupancy increased by 310.8 bps to 36.2%.

The primary driver of increased revenue was the rise in Average Daily Rate (ADR), which grew across all three operating segments. The most significant growth was observed in the campsites segment, particularly in the renovated properties - Arena Stupice Campsite and Arena Indije Campsite. Additionally, the holiday calendar contributed positively, with more public holidays falling in the warmer month of June, which traditionally boosts demand in summer leisure destinations. June, in particular, marked a historic milestone for AHG d.d., recording the strongest performance ever in its leisure destinations in Istria. Another notable contributor was art'otel Zagreb, which achieved a 20% year-over-year revenue increase during the reporting period.

On the cost side, we successfully maintained payroll expenses at a level comparable to last year, despite a 15,5% increase in the national minimum wage, which resulted in an average payroll increase of 6%. This was achieved primarily due to the later start of the holiday season this year, which delayed the opening of our properties and consequently postponed the recruitment of seasonal staff.

Operating expenses rose by 8% year-over-year, primarily due to a 13% increase in maintenance costs and higher accommodation operating expenses, and elevated sales and marketing expenditures. The rise in accommodation-related costs is attributed to both increased revenue and the enhancement of property standards, which led to the provision of higher-quality services in renovated properties.

As a result, reported EBITDA increased significantly, reaching EUR 1.1 million, compared to a profit of EUR 0.2 million in 2024.

In the first six months of 2025 the region realised an occupancy rate of 66.2%, compared to 65.9% in 2024. The region saw a decline in ADRs compared to 2024, and amounted EUR 127.1 (2024: EUR 140.5).

Total revenue during the period decreased compared to last year and amounted EUR 12.9 million (2024: EUR 14.0 million). Accommodation revenues decreased by 9.2% to EUR 10.9 million (2024: EUR 12.0 million) driven by slight decline in rooms available and decrease of 9.5% in ADR (EUR 127.1), while occupancy increased by 31.0 bps to 66.2% (2024: 65.9%). RevPAR decreased by 9.0% to EUR 84.1 (2024: EUR 92.5).

The decrease in revenue is primarily due to the absence of major sporting events in June, which were held last year in Berlin and Cologne, as well as a reduction in the number of trade fair events in Nuremberg.

While we maintained expenses at the same level as last year, the decline in revenue led to a decrease in EBITDA, which amounted to EUR 2.8 million, compared to EUR 3.8 million in 2024.

The CEE operating region—comprising Hungary, Serbia, and Austria—reported a notable increase in business activity during the first half of the year.

Our hotel in Budapest continued its positive performance, increasing occupancy to 75.9% (up from 66.2% in 2024) and achieving a 6% year-on-year revenue growth. Although ADR declined due to a shift in market mix and strategic adjustments, the rise in occupancy drove a 6% increase in accommodation revenue.

Our hotel in Nassfeld (Austria) recorded also positive performance with a 12% year-on-year increase in revenues, which is the result of growth in both ADR and occupancy.

Considering the increasingly unstable political situation in Belgrade, our Radisson RED hotel managed to finish the first six month with an improved revenue and EBITDA result compared to previous year.

Overall, total revenue for the CEE region rose by 12.9% to EUR 7.0 million (2024: EUR 6.2 million). The average daily rate reached EUR 140.4, while occupancy stood at 60.6%. EBITDA increased to EUR 1.3 million, up from EUR 0.9 million in 2024.

In line with the operations in Croatia and our international operations, total reported revenue increased by 6.7% to EUR 8.0 million (2024: EUR 7.5 million). External revenues increased by 25% compared to last year and amounted to EUR 0.5 million. EBITDA loss amounted to EUR 1.6 million (2024: loss EUR 1.7 million).

ESG and Sustainability Report

Development of the Decarbonisation Plan

In 2024, Arena Hospitality Group began exploring decarbonisation pathways and the Science Based Targets initiative (SBTi), in collaboration with PPHE Hotel Group. Since then, meaningful progress has been made with the support of external experts from Greenview, who have been engaged since early 2025.

In June 2025, a cross-functional team from Arena – including the CFO, ESG Manager, Technical Manager, and Purchasing Manager – participated in a two-day workshop dedicated to developing the company's decarbonisation plan and deepening its understanding of SBTi requirements.

The sessions covered key topics such as energy reduction pathways and Scope 3 emissions strategies, in line with SBTi guidance. This initiative marked an important step toward shaping Arena's long-term sustainability strategy and aligning operations with globally recognised climate goals.

Scholarship in Memory of Prof. Dr. Igor Štoković

In April 2025, Arena Hospitality Group launched a scholarship in memory of Prof. Dr. Igor Štoković, intended for second-year graduate students enrolled in the "Culture and Tourism" and "Tourism and Development" programmes at the Faculty of Economics and Tourism in Pula.

Prof. Dr. Štoković served as CEO of Arenaturist from 1999 until his passing on April 9, 2015. Through this initiative, Arena aims to support outstanding students in completing their education and advancing their professional development by providing financial assistance and internship opportunities within the company.

Arena Wellbeing

Mental Health Workshop

As part of the Arena Hospitality Group's Wellbeing program, the third workshop in the series – titled "No Man Is an Island" – was held in April, focusing on the importance of close relationships for emotional and psychological well-being.

The session explored how to build and maintain healthy interpersonal connections as a foundation for both personal wellness and team cohesion. Like previous sessions in the series, the workshop was delivered in a hybrid format – held live with an option to join online.

The workshop series will continue in Q3.

Multisport Benefits for Employees

As part of the Arena Hospitality Group's Wellbeing program, the company joined the Multisport initiative in Q1 2025, enabling employees in Pula, Medulin, and Zagreb to access a variety of sports and recreational activities at discounted rates.

The program continued into Q2 and currently includes over 150 employees. Employees also have the option to share the benefits of the Multisport card with family members, who can enjoy the same discounts.

Arena in the Community

Arena Hospitality Group at the Impact & Connect Event: Dialogues on Tourism Resilience

At the VII. Impact & Connect After-Work Event, held in April in Zagreb, ESG Manager Sandra Kalagac represented Arena Hospitality Group in discussions focused on building tourism resilience in the context of climate change.

Key topics included sustainable resource management, the implementation of development strategies, and innovative solutions such as eco-friendly moorings. The event concluded that fostering sectoral resilience requires strong collaboration between the private sector, academia, and policymakers.

Continued Engagement in the BIOCENTUM Working Group and Participation in the EU Project URBIO BAUHAUS

In Q1, Arena representatives joined the BIOCENTUM working group, organised by the City of Pula in support of the EU project URBIO BAUHAUS, implemented under the Interreg Central Europe 2021–2027 programme.

In Q2, the team continued its active involvement. A workshop titled "Project in a Day" was held, gathering BIOCENTUM members – who serve as an advisory body within the project – as well as additional stakeholders working on biodiversity preservation. The event further strengthened cross-sector collaboration and knowledge sharing.

In June, the project team compiled and presented the outcomes of all activities and proposals to date. Community-focused biodiversity initiatives will continue into Q3.

Earth Day: Symbolic Tree Planting and Ongoing Environmental Commitment

To mark Earth Day, Arena's horticulture team planted four cypress trees near the Aquarium in Verudela, Pula. This symbolic gesture is part of the broader "Compensating by Planting" project, through which Arena has been contributing to reforestation efforts in Croatia over the past two years.

The most recent reforestation activity took place in Q1 2025 in the Valdebek district of Pula.

SIGNIFICANT EVENTS DURING SIX MONTHS OF 2025

New financing

The Group has withdrawn a long-term loan based on previous arrangements with OTP bank d.d. amounting to a total of EUR 3.0 million, for a upgrade investment projects of Arena Stupice and Arena Indije Campsites, with a fixed interest rate of 3.7% and maturing in 2032.

Dividend payout

In line with the Company's dividend policy and based on an approval at the Company's Annual General Assembly in May 2025, the dividend in the amount of EUR 1,10 per share in respect of 2024 financial year was paid to shareholders.

Note 1 General

The interim financial statements of Arena Hospitality Group d.d. (the Company) and its subsidiaries (together the Group) for the period ended 30 June 2025 were established by a decision of the Management Board dated 28 July 2025.

The Company is a subsidiary of PPHE Hotel Group Limited, a Guernsey incorporated company listed on the FTSE Market of the London Stock Exchange (PPHE Hotel Group) which (indirectly) owns 64.59% (excluding treasury shares) of the registered share capital in the Company.

Description of business and formation of the Company: The Company is a joint stock company listed on the Prime Market of the Zagreb Stock Exchange with its registered office in Pula, Republic of Croatia. In accordance with the laws of the Republic of Croatia and with the approval of the Croatian Privatisation Fund, the Company was transformed from a state-owned company into a joint stock company in 1994 and registered with the Commercial Court in Rijeka. The business of the Group is owning, co-owning, leasing and operating full—service upscale, upper upscale and lifestyle hotels in major gateway cities and regional centres, such as Berlin, Cologne and Nuremberg in Germany, Budapest in Hungary, Belgrade in Serbia, Zagreb in Croatia, as well as hotels self-catering apartment complexes and campsites in destinations such as in the city of Pula, the largest city in Croatia's Istria region or Medulin, and a ski resort in Nassfeld in Austria.

These financial statements have been prepared in a condensed format as at 30 June 2025 and for the six months then ended ("interim financial statements"). These financial statements should be read in conjunction with the Company's annual financial statements as at 31 December 2024 and for the year then ended and the accompanying notes ("annual financial statements").

Going concern:

The Management Board continues to monitor the Group's cash flow forecasts for a period of at least 12 months from the date of approval of the financial statements, including compliance with loan covenants and liquidity risks arising from the maturities of the Group's loans. The Board believes that the Group has adequate resources and will generate sufficient funds in the future to serve its financial obligations and continue its operations as a going concern in the foreseeable future.

Note 2 Basis of Preparation and Changes in Accounting Treatment

Basis of preparation:

The interim financial statements have been prepared in accordance with IAS 34 "Interim Financial Reporting" as adopted in the European Union. The accounting policies adopted in the preparation of the interim condensed financial statements are consistent with those followed in the preparation of the Group's annual financial statements as of 31 December 2024.

There are no new accounting pronouncements that were issued after the issuance of annual report, and no new standards were applied in preparation of these interim condensed consolidated financial statements.

Critical accounting estimates:

There were no changes in critical accounting estimates used for preparation of condensed financial statements for the period ended 30 June 2025 comparing to those used for the preparation of the Group's annual financial statements for the year ended 31 December 2024.

Seasonality

The Company operates in Croatia in an industry with seasonal variations. Sales and profits vary by quarter and the second half of the year is generally the strongest trading period.

Most of the Company's revenues are realised in the second and third quarter of the year (during the summer period).

In contrast to the above, the strongest period for our ski resort in Nassfeld, Austria is the first quarter. In our other (city) hotels, the variation in operations during the year is not so significant and revenues are generated throughout the year.

Note 7 Related parties

Parties are considered to be related if one of the parties has the power to exercise control over the other party or if it has significant influence over the other party in making financial and/or operational decisions. The Company is controlled by Dvadeset Osam d.o.o., which owns 63.79% of the Company's shares (64.59% excluding treasury shares) as at 30 June 2025. The Company's ultimate parent is PPHE Hotel Group Limited which indirectly owns 100% of the shares of Dvadeset Osam d.o.o. All other subsidiaries of PPHE Hotel Group Limited are also treated as related parties. 03 PRINCIPAL RISKS OF THE GROUP AND THE COMPANY

Our principal risks and uncertainties are set out in the Company's financial statements for the year ended 31 December 2024. We continually assess and monitor our changing risk management environment.

We are aware and closely monitoring the emerging risks associated with global geopolitical situation leading to economic fragmentation linked to trade policies and their potential impact. Thus far we have not experienced any supply chain related adverse issues impacting our business in Europe. Other key factors are persistent inflation, fluctuations in currency rates and the ongoing conflicts in Ukraine and Middle East.

Inflation is impacting the current cost of procuring goods and services, which is difficult to mitigate. The ongoing conflict events are maintaining high volatility of fuel and energy prices. All of these are putting pressure on financial performance. These changes are being viewed in short to medium term, however difficult to assess the lasting effects of these economic developments. These cost increases are being recouped and reflected in customer pricing for the foreseeable future.

The Group continues to procure and spend in the currency of its income as much as possible therefore the impact of currency fluctuations is minimised to a great deal. We have hedged a proportion of our 2025 gas and electricity volumes to an optimal level thus mitigating price volatility across most regions in which the Group operates.

We are not experiencing any major supply chain issues that impact our ability to serve our customers effectively and we are able to deliver quality service as usual.

The Group's borrowings carry competitive fixed interest rates; therefore, we have not experienced adverse interest rates variances.

The most significant of these risks at the moment relate to factors that are common to the hotel industry and beyond the Group's control. Notwithstanding the limited control the Group has over these risks, continuous efforts are taken to ensure the Group can utilise resources and assets to act with agility and continue to attract revenue sources under strained market conditions. Additionally, the Group is well positioned to weather these risks in a socially responsible manner through cost rationalisation and prioritising commercial activities which benefit the long-term interests of the Group and its stakeholders.

For a detailed discussion of the risks facing the Group, please refer to pages from 146 to 151 of the 2024 Annual Report.

04 CORPORATE GOVERNANCE REPORT

Corporate Governance code

The Company applies the Corporate Governance Code of the Zagreb Stock Exchange 2025 (the New Code) as adopted by the Croatian Financial Services Supervisory Agency and the Zagreb Stock Exchange (the ZSE) in December 2024 based on the "comply or explain" principle. The Company abides by this principle and, where relevant, provides reasons for non-compliance. The Company published its annual Corporate Governance Questionnaires (Compliance Questionnaire) for 2024, in which it provided details on application of the Corporate Governance Code adopted in October 2019, within the deadlines specified in the relevant regulations. The Company also applies the Rules of the ZSE (the ZSE Rules) in its day-to-day business.

General Assembly meeting

The General Assembly of the Company took place on 29th May 2025. On that General Assembly:

- the Company's Annual Report for 2024 (consolidated and separate) together with the Sustainability Report and the annual financial statements of the Company for 2024, the Report of the Supervisory Board on supervision of the Company's management and the results of examination of the Company's Annual Report for 2024, as well as the Report of the Management Board on acquisition of treasury shares were considered;
- the decision on adoption of the Report on remuneration of the Management Board and Supervisory Board members in 2024 was adopted;
- the decision on distribution of profits realised in 2024 was adopted;
- the decision on granting discharge to the members of the Supervisory Board for their work in 2024 was adopted;
- the decision on granting discharge to the members of the Management Board for their work in 2024 was adopted;
- the decision on Amendments to the Company's Articles of Association was adopted;
- the decision of the dividend payout in the amount of 1,10 EUR per share was adopted;
- the decision on appointment of the Company's auditor for 2025 and 2026 was adopted.

Supervisory Board Meetings

The members of the Supervisory Board are: Boris Ernest Ivesha (Chairman), Yoav Arie Papouchado (Vice-Chairman), Kevin Michael McAuliffe, Ivana Matovina, Amra Pende, Lorena Škuflić and Goran Nikolić.

The Supervisory Board of the Company held two meetings in the first six months of 2025:

- on 26 February 2025, whereat, *inter alia*, the Supervisory Board decided on adopting the Annual Report of the Company for the year 2024, together with the Sustainability Report and the annual financial statements of the Company for the year 2024 (audited, consolidated and separate) and the proposal for the dividend payout in the amount of EUR 1,10 (in words: one euro and ten cents) per each share was adopted;
- on 23 April 2025, whereat, *inter alia*, the Supervisory Board discussed on unaudited consolidated and separate quarterly report of the Company for the first quarter of 2025, as well as other decisions related to the Annual General Assembly of the Company was adopted.

Supervisory Board Committees

In the first six months of 2025 the following Supervisory Board Committees' meetings were held:

- the Audit Committee held a meeting on 24 February 2025, whereat, inter alia, it considered the financial statements of the Company for 2024 (audited, consolidated and separate) and the Sustainability Report for 2024, the Audit Committee Report for 2024 was adopted as well as the recommendation on the dividend payout to the Company's shareholders. It also held the meeting on 22 April 2025, whereat, inter alia, the recommendation for the appointment of the Company's auditor for the year 2025 and 2026 was adopted as well as unaudited, consolidated and separate quarterly report of the Company for the first quarter of 2025 was discussed;
- the Remuneration Committee held a meeting on 25 February 2025, whereat, *inter alia*, the recommendation to the Supervisory Board in relation to adoption of the Report on remuneration of Management Board and Supervisory Board members for 2024 were adopted;
- Sustainability Committee held a meeting on 24 February 2025, whereat, inter alia, the Sustainability Report for 2024 was considered.

Management Board meetings

The Management Board primarily adopts its decisions in meetings and by correspondence in accordance with the applicable laws and the Company's Articles of Association. The Management Board has regular monthly (and more often, if needed) meetings to review operational activities in the Group. The minutes from such meetings are kept for the purposes of future needs and analyses.

- on 28 February 2025, whereat, inter alia, the interim report of the Company for the fourth quarter
 of 2024 (consolidated and separate) and the Annual Report, including the Sustainability Report

 payout to the Company's shareholders were adopted;
- on 23 April 2025, whereat, *inter alia*, the unaudited consolidated and separate quarterly report of the Company for the first quarter of 2025 was adopted.
