Pursuant to Article 474 of the Capital Market Act, Arena Hospitality Group d.d. ("the Company") hereby notifies that the investment company Interkapital vrijednosni papiri d.o.o. made the following acquisitions of Company (treasury) shares, in the name and on behalf of the Company, at the regulated market of Zagreb Stock Exchange (ZSE), in line with the Treasury Share Buyback Program:

- On 25 October 2022, 112 shares, identification code ARNT, were acquired at a weighted average price of HRK 242.00 per share, representing 0.00218 % of the Company's issued share capital.
- On 26 October 2022, 114 shares, identification code ARNT, were acquired at a weighted average price of HRK 244.00 per share, representing 0.0022 % of the Company's issued share capital.

Following these acquisitions, the Company holds in total 65,067 treasury shares, representing 1.268679 % of the Company's issued share capital. Share capital amounts to HRK 102,574,420.00, and it is divided into 5,128,721 shares without nominal value.
