(3) of the Regulation (EU) No 596/2014 (Market Abuse Regulation) and pursuant to the provisions of the Capital Market Act and Zagreb Stock Exchange Rules, Arena Hospitality Group d.d. (the "Company") hereby notifies that on 4 March 2024 the company Dvadeset Osam d.o.o. Zagreb (member of PPHE Hotel Group), as a person closely associated with persons discharging managerial responsibilities in the Company, acquired 23,029 shares of the Company representing 0.449% of the Company's issued share capital.

Following this acquisition, the company Dvadeset Osam d.o.o. Zagreb holds in total 2,734,752 shares of the Company, representing 53.322% of the Company's issued share capital and 54.236% of the Company's voting shares as at 5 March 2024 respectively.


