("the Company") hereby notifies that the investment company Interkapital vrijednosni papiri d.o.o. made the following acquisition of Company (treasury) shares, in the name and on behalf of the Company, at the regulated market of Zagreb Stock Exchange (ZSE), in line with the Treasury Share Buyback Program:

- On 25 January 2024, 60 shares, identification code ARNT, were acquired at a weighted average price of EUR 30.60 per share, representing 0.0012% of the Company's issued share capital.
