(the "Company") hereby notifies that on 16 September 2025 the company Dvadeset Osam d.o.o. Zagreb (member of PPHE Hotel Group), as a person closely associated with persons discharging managerial responsibilities in the Company, acquired 8,776 shares of the Company representing 0.171% of the Company's issued share capital.

Following this acquisition, the company Dvadeset Osam d.o.o. Zagreb holds in total 3,280,208 shares of the Company, representing 63.958% of the Company's issued share capital and 65.960% of the Company's voting shares as of 18 September 2025 respectively.
