Pursuant to Article 474 of the Capital Market Act, Arena Hospitality Group d.d. ("the Company") hereby notifies that the investment company Interkapital vrijednosni papiri d.o.o. made the following acquisitions of Company (treasury) shares, in the name and on behalf of the Company, at the regulated market of Zagreb Stock Exchange (ZSE), in line with the Treasury Share Buyback Program:

- On 12 December 2023, 111 shares, identification code ARNT, were acquired at a weighted average price of EUR 29.9964 per share, representing 0.0022% of the Company's issued share capital.
- On 13 December 2023, 100 shares, identification code ARNT, were acquired at a weighted average price of EUR 30.00 per share, representing 0.0019% of the Company's issued share capital.

Following these acquisitions, the Company holds in total 85,333 treasury shares, representing 1.663826% of the Company's issued share capital. Share capital amounts to EUR 13,613,965.00, and it is divided into 5,128,721 shares without nominal value.
