Pursuant to Article 474 of the Capital Market Act, Arena Hospitality Group d.d. ("the Company") hereby notifies that the investment company Interkapital vrijednosni papiri d.o.o. made the following acquisitions of Company (treasury) shares, in the name and on behalf of the Company, at the regulated market of Zagreb Stock Exchange (ZSE), in line with the Treasury Share Buyback Program:

- On 01 August 2025, 210 shares, identification code ARNT, were acquired at a weighted average price of EUR 39.6666 per share, representing 0.0041% of the Company's issued share capital.
- On 04 August 2025, 250 shares, identification code ARNT, were acquired at a weighted average price of EUR 39.8666 per share, representing 0.0049% of the Company's issued share capital.

Following these acquisitions, the Company holds in total 150,983 treasury shares, representing 2.943872% of the Company's issued share capital. Share capital amounts to EUR 13,613,965.00, and it is divided into 5,128,721 shares without nominal value.
