(the "Company") hereby notifies that on 17 March 2026 and 19 March 2026 the company Dvadeset Osam d.o.o. Zagreb (member of PPHE Hotel Group), as a person closely associated with persons discharging managerial responsibilities in the Company, acquired in total 20,000 shares of the Company representing 0,390% of the Company's issued share capital.

Following this acquisition, the company Dvadeset Osam d.o.o. Zagreb holds in total 3.300.208 shares of the Company, representing 64,348% of the Company's issued share capital and 66,315% of the Company's voting shares as of 19 March 2026 respectively.
