Announcement of regulated information

Pursuant to Article 474 of the Capital Market Act, Arena Hospitality Group d.d. ("the Company") hereby notifies that the investment company Interkapital vrijednosni papiri d.o.o. made the following acquisitions of Company (treasury) shares, in the name and on behalf of the Company, at the regulated market of Zagreb Stock Exchange (ZSE), in line with the Treasury Share Buyback Program:

- On 06 February 2023, 114 shares, identification code ARNT, were acquired at a weighted average price of EUR 32.00 per share, representing 0.0022 % of the Company's issued share capital.
- On 07 February 2023, 86 shares, identification code ARNT, were acquired at a weighted average price of EUR 32.00 per share, representing 0.0017 % of the Company's issued share capital

Following these acquisitions, the Company holds in total 72,699 treasury shares, representing 1.417488% of the Company's issued share capital. Share capital amounts to HRK 102,574,420.00 / EUR 13,613,965.09, and it is divided into 5,128,721 shares without nominal value.
