Pursuant to Article 474 of the Capital Market Act, Arena Hospitality Group d.d. ("the Company") hereby notifies that the investment company Interkapital vrijednosni papiri d.o.o. made the following acquisitions of Company (treasury) shares, in the name and on behalf of the Company, at the regulated market of Zagreb Stock Exchange (ZSE), in line with the Treasury Share Buyback Program:

- On 20 July 2026, 271 shares, identification code ARNT, were acquired at a weighted average price of EUR 40.7011 per share, representing 0.0053% of the Company's issued share capital.
- On 21 July 2026, 160 shares, identification code ARNT, were acquired at a weighted average price of EUR 40.00 per share, representing 0.0031% of the Company's issued share capital.

Following these acquisitions, the Company holds in total 160,723 treasury shares, representing 3.133783% of the Company's issued share capital. Share capital amounts to EUR 13,613,965.00, and it is divided into 5,128,721 shares without nominal value.
