(3) of the Regulation (EU) No 596/2014 (Market Abuse Regulation) and pursuant to the provisions of the Capital Market Act and Zagreb Stock Exchange Rules, Arena Hospitality Group d.d. (the "Company") hereby notifies that on 7 May 2025 the company Dvadeset Osam d.o.o. Zagreb (member of PPHE Hotel Group), as a person closely associated with persons discharging managerial responsibilities in the Company, acquired 483,711 shares of the Company representing 9.431% of the Company's issued share capital.

Following this acquisition, the company Dvadeset Osam d.o.o. Zagreb holds in total 3,271,432 shares of the Company, representing 63.787% of the Company's issued share capital and 65.542% of the Company's voting shares as of 7 May 2025 respectively.
