Pursuant to Article 474 of the Capital Market Act, Arena Hospitality Group d.d. ("the Company") hereby notifies that the investment company Interkapital vrijednosni papiri d.o.o. made the following acquisition of Company (treasury) shares, in the name and on behalf of the Company, at the regulated market of Zagreb Stock Exchange (ZSE), in line with the Treasury Share Buyback Program:

- On 26 January 2023, 1,000 shares, identification code ARNT, were acquired at a weighted average price of EUR 32.60 per share, representing 0.0195 % of the Company's issued share capital.

Following this acquisition, the Company holds in total 71,569 treasury shares, representing 1.395455 % of the Company's issued share capital. Share capital amounts to HRK 102,574,420.00 / EUR 13,613,965.09, and it is divided into 5,128,721 shares without nominal value.
