# Financial results for the period ended 31 March 2024:

In the period ended 31 March 2024 Atlantic Grupa d.d. reported EUR 7,694,564 of operating income, which is a increase of 8% compared to the same period last year. The main part of income relates to other operating income with undertakings within the Group.

In the same period, Atlantic Grupa d.d. realized EUR 7,389,163 of operating costs, which is 8% more compared to the same period of the last year. The most significant part of operating costs are employee expenses in the amount of EUR 3,601,290 which include net salaries, taxes and contributions from salary expenses and contributions on salary, and other expenses in the amount of EUR 1,600,802 which include maintenance, intellectual and other services.

In the period ended 31 March 2024, financial expenses amounted EUR 181,426 and loss of EUR 171,952 was realized.
