Financial results for the period ended 30 June 2025:

In the period ended 30 June 2025 Atlantic Grupa d.d. reported EUR 32,167,115 of operating income, which is a increase of 9% compared to the same period last year. The main part of income relates to other operating income with undertakings within the Group.

In the same period, Atlantic Grupa d.d. realized EUR 16,794,976 of operating costs, which is 7% higher compared to the same period of the last year. The most significant part of operating costs are employee expenses in the amount of EUR 9,851,682 which include net salaries, taxes and contributions from salary expenses and contributions on salary, and other expenses in the amount of EUR 2,547,400 which include maintenance, intellectual and other services.

In the period ended 30 June 2025, financial expenses amounted EUR 993,422 and loss of EUR 13,828,661 was realized.
