Pursuant to the Article 474 paragraph 1 of the Capital Markets Act, Atlantic Grupa d.d., Zagreb, Miramarska 23 (hereinafter also as: the Company) informs that, pursuant to the Optional Award program and the awarding politics of Atlantic Grupa, with the purpose of its realization among its employees, that on 25 November 2024, it has transferred 885 of its own shares of the total nominal amount of EUR 7,080.00, which represent 0.007% of subscribed capital of the Company, to its employees. Before such transfer, the Company had 79,350 of its own shares, of the total nominal value of EUR 634,800.00, which represent 0.6% of subscribed capital of the Company. After the transfer the Company holds 78,465 of its own shares, with the total nominal value of HRK 627,720.00 which represent 0.59% of subscribed capital of the Company.
