The said shares, with a total nominal amount of EUR 1,344.00, constitute 0.001% of the Company's share capital, or 0.001% of the votes at the General Assembly of the Company. Prior to the said disposal, the member of the Management Board Srećko Nakić owned 33,968 shares of Atlantic Grupa d.d., with a total nominal amount of EUR 271,744.00, which constitute 0.25% of the Company's share capital, or 0.25% of the votes at the General Assembly of the Company. Following the aforementioned disposal, the member of the Management Board Srećko Nakić owns 33,800 shares of the Company, with a total nominal amount of EUR 270,400.00, which constitute 0.25% of the Company's share capital, i.e., they grant 0.25% of the votes at the General Assembly of the Company.
