Notice on the acquisition of own shares, transfer of own shares in accordance with the Remuneration Policy for members of the Management Board, and acquisition of shares by a person performing managerial duties

Atlantic Grupa d.d., Miramarska 23, Zagreb (hereinafter: "Company") announces that on 16 September 2025 the Company acquired 15,000 own shares, with a total nominal amount of EUR 120,000.00, representing 0.11% of the Company's share capital. Before the transfer, the Company owned 60,472 shares with a total nominal amount of EUR 483,776.00, representing 0.45% of the Company's share capital, while after the transfer, the Company owned 75,472 own shares with a total nominal amount of EUR 603,776.00, representing 0.57% of the Company's share capital.

The Company also announces that, in accordance with the Remuneration Policy for members of the Management Board, on 17 September 2025, the Company released 200 treasury shares, with a total nominal amount of EUR 1,600.00, representing 0.01% of the Company's share capital, or 0.01% of the votes at the General Assembly of the Company, and allocated them to Management Board member Mojca Domiter. After the aforementioned allocation of shares, the Company owns 75,272 treasury shares, with a total nominal amount of EUR 602,176.00, representing 0.56% of the Company's share capital, or 0.56% of the votes at the General Assembly of the Company.

Prior to the aforementioned acquisition, the member of the Management Board Mojca Domiter did not hold any shares in the Company, which is why the acquired 200 shares of the Company, with a total nominal amount of EUR 1,600.00, which constitute 0.01% of the Company's share capital, or 0.01% of the votes at the General Assembly of the Company, constitute the total number of shares of Atlantic Grupa d.d. held by her.
