The said shares, with a total nominal amount of EUR 9,600.00, constitute 0.01% of the Company's share capital, or 0.01% of the votes at the General Assembly of the Company,

Prior to the said disposal, the member of the Management Board Mate Štetić owned 12,942 shares of the Company, with a total nominal amount of EUR 103,536.00, which constitute 0.1% of the Company's share capital, i.e., they grant 0.1% of the votes at the General Assembly of the Company. Following the aforementioned disposal, the member of the Management Board Mate Štetić owns 11,742 shares of the Company, with a total nominal amount of EUR 93,936.00 which constitute 0.09% of the Company's share capital, i.e., they grant 0.09% of the votes at the General Assembly of the Company.
