Atlantic Grupa d.d., Miramarska 23, Zagreb (hereinafter: the Company or the Issuer) hereby announces the disposal of shares of the Issuer, conducted by Srećko Nakić, a member of Management Board:

- 32 shares by a transaction executed on 13 January 2026 on the regulated market of the Zagreb Stock Exchange. The said shares, with a total nominal amount of EUR 256, constitute 0.0002% of the Company's share capital, or 0.0002% of the votes at the General Assembly of the Company,
- 468 shares by a transaction executed on 14 January 2026 on the regulated market of the Zagreb Stock Exchange. The said shares, with a total nominal amount of EUR 3.744,00, constitute 0.004% of the Company's share capital, or 0.004% of the votes at the General Assembly of the Company,

Prior to the said disposal, the member of the Management Board Srećko Nakić owned 32,900 shares of the Company, with a total nominal amount of EUR 263,200.00, which constitute 0.25% of the Company's share capital, i.e., they grant 0.25% of the votes at the General Assembly of the Company. Following the aforementioned disposal, the member of the Management Board Srećko Nakić owns 32,400 shares of the Company, with a total nominal amount of EUR 259,200.00 which constitute 0.24% of the Company's share capital, i.e., they grant 0.24% of the votes at the General Assembly of the Company.
