Atlantic Grupa d.d., Miramarska 23, Zagreb (hereinafter referred to as: the Company) hereby announces the allocation of 1,000 shares of the Company, carried out on 16 January 2026. The allocation was made in accordance with the Remuneration Policy for Management Board members of Atlantic Grupa d.d., pursuant to which Management Board member Srećko Nakić acquired 400 shares of the Company, with a total nominal amount of EUR 3,200.00, which constitute 0.003% of the Company's share capital, or 0.003% of the votes at the General Assembly of the Company, while Management Board member Mate Štetić acquired 600 shares of the Company, with a total nominal amount of EUR 4,800.00, which constitute 0.005% of the Company's share capital, or 0.005% of the votes at the General Assembly of the Company.

Prior to the aforementioned acquisition, Management Board member Srećko Nakić held 32,400 shares of the Company, with a total nominal amount of EUR 259,200.00, which constitute 0.24% of the Company's share capital, i.e., they give 0.24% of the votes at the General Assembly of the Company, while after the acquisition, the member of the Management Board Srećko Nakić holds 32,800 shares of the Company, with a total nominal amount of EUR 262,400.00, which constitute 0.25% of the Company's share capital, i.e., they give 0.25% of the votes at the General Assembly of the Company. Prior to the aforementioned acquisition, Management Board member Mate Štetić held 8,323 shares of the Company, with a total nominal amount of EUR 66,584.00, which constitute 0.07% of the Company's share capital, or 0.07% of the votes at the General Meeting of the Company, while after the acquisition, Management Board member Mate Štetić holds 8,923 shares of the Company, with a total nominal amount of EUR 71,384.00, which constitute 0.07% of the Company's share capital, or 0.07% of the votes at the General Meeting of the Company.
