Announcement on transfer of Company's shares in accordance with the Company's Optional Award program and the awarding politics and notice on the acquisition of shares by persons entrusted with managerial duties

Pursuant to the Article 474 paragraph 1 of the Capital Markets Act and the Optional Award program and the awarding politics of Atlantic Grupa, with the purpose of its realization among its management and employees, the Company informs that, on 20 April 2022, it has transferred 13.988 of its own shares, of the total nominal amount of HRK 559.520,00, which represent 0.42% of subscribed capital of the Company, to its employees. Before such transfer, the Company had 17,926 of its own shares of the total nominal value of HRK 717,040.00 which represent 0.54% of subscribed capital of the Company. After the transfer the Company had 3,938 of its own shares, with the total nominal value of HRK 157,520.00 which represent 0.12% of subscribed capital of the Company.

Member of the Management Board Neven Vranković was awarded with 821 Atlantic Grupa shares, of a total nominal amount of HRK 32,840.00 which represent 0.02% of subscribed capital of the Company and provide 0.02% votes at the General Assembly. 
