## Leadership Change at Ericsson Nikola Tesla

Zagreb, September 25, 2025

 Gordana Kovačević at her own request is stepping down from the position of President of the Management Board (CEO) of Ericsson Nikola Tesla d.d. (ENT) as of November 1st of this year. At its meeting held on September 25, 2025, the Supervisory Board of Ericsson Nikola Tesla d.d. appointed Siniša Krajnović as the new President of the Management Board (CEO), effective November 1, 2025.

Gordana Kovačević has submitted her resignation from the position of President of the Management Board of Ericsson Nikola Tesla following nearly 21 years at the helm of the company.

Her resignation is effective from November 1, 2025.

**Ms. Kovačević**, M. Sc., has dedicated her entire professional career to Ericsson Nikola Tesla. She commenced her distinguished career within the company as a talented engineer and was soon recognized as an expert capable of leading the most complex telecommunications projects in both domestic and international markets. As an accomplished executive, she subsequently assumed responsibility for managing the company's largest line organizations.

Following Ericsson's entry into the ownership structure, she became Vice President of ENT and Vice President of the Market Unit Central Europe, where she had significant responsibility in implementing Centers of Excellence both in Croatia and within the global corporation. She has obtained as President of Ericsson Nikola Tesla since 2005, leaving a lasting mark in the development of the company, the industry, and the broader community. Ms. Kovačević has successfully overseen the organizational restructuring, internationalization, and digital transformation of the company's operations.

Furthermore, she maintains active engagement with academic and business institutions and currently presides over the Economic Council of the University of Zagreb.

She has been honored with numerous distinguished national and international awards and recognitions, including state honors.

Siniša Krajnović, who is appointed as the new President of the Management Board of Ericsson Nikola Tesla, will begin serving this role in the company on November 1, 2025.





Mr. Siniša Krajnović is coming to his new CEO role in ENT from the current position of Partner in McKinsey & Company. Since 2022, he has been a core member of the McKinsey & Company's Technology, Media & Telecommunications practice. Drawing on his deep knowledge of technology and broad business experience, he has specialized in issues related to the telecom industry, research and product development, and digital transformation. Before joining McKinsey, he was Executive Vice President at Ericsson Northeast Asia, where he led operations in the world's most advanced 5G markets. He started his career in Ericsson Nikola Tesla in 1994 in Zagreb, as an engineer in its R&D center, and spent 10 years in the company. Dr. Krajnović has for the most part of his career worked in Ericsson Corporation, and, among his various senior executive positions, he led Ericsson's global R&D organization. He has extensive international experience in leadership and technology and throughout his professional journey, except in Croatia, he has also worked in Sweden, China, Japan, Ireland, Hungary and the United Kingdom.

He earned his M.Sc. and Ph.D. degrees from the Faculty of Electrical Engineering and Computing at the University of Zagreb and furthered his education at prestigious universities around the world.
