- On November 11, 2025, 448 shares, identification code ERNT-R-A, were acquired at average price of EUR 194.93 per share, representing 0.034% of the Company's share capital.

- On November 12, 2025, 395 shares, identification code ERNT-R-A, were acquired at average price of EUR 196.86 per share, representing 0.03% of the Company's share capital.

Following these acquisitions Ericsson Nikola Tesla d.d. holds 13,420 own shares, representing 1.01% of the Company's share capital.

The Company acquires its treasury shares with the purpose to award shares to employees under the Award Programs.
