- On September 15, 2025, 719 shares, identification code ERNT-R-A, were acquired at average price of EUR 185.9033 per share, representing 0.054% of the Company's share capital.

Following this acquisition Ericsson Nikola Tesla d.d. holds in 8,093 own shares, representing 0.61% of the Company's share capital.

The Company acquires its treasury shares with the purpose to award shares to employees under the Award Programs.
