investment company FIMA-VRIJEDNOSNICE d.o.o. made the following acquisition of Company (treasury) shares in the name and on behalf of the Company at the regulated market of Zagreb Stock Exchange (ZSE).

- On November 07, 2025, 449 shares, identification code ERNT-R-A, were acquired at average price of EUR 193.62 per share, representing 0.03% of the Company’s share capital.

- On November 10, 2025, 574 shares, identification code ERNT-R-A, were acquired at average price of EUR 194.249 per share, representing 0.04% of the Company’s share capital.

Following these acquisitions Ericsson Nikola Tesla d.d. holds 12,577 own shares, representing 0.94% of the Company’s share capital.

The Company acquires its treasury shares with the purpose to award shares to employees under the Award Programs.
