Pursuant to the Article 474, Paragraph 1 of the Capital Market Act, Ericsson Nikola Tesla d.d., with headquarters in Zagreb, Krapinska 45, PIN: 84214771175 (hereinafter: "the Company"), hereby notifies the following:

investment company Interkapital vrijednosni papiri d.o.o. made the following acquisitions of Company (treasury) shares in the name and on behalf of the Company at the regulated market of Zagreb Stock Exchange (ZSE).

- On October 28, 2025, 65 shares, identification code ERNT-R-A, were acquired at average price of EUR 185.60 per share, representing 0.005% of the Company's share capital.
- On October 29, 2025, 84 shares, identification code ERNT-R-A, were acquired at average price of EUR 189.10 per share, representing 0.006% of the Company's share capital.

Following these acquisitions Ericsson Nikola Tesla d.d. holds 10,834 own shares, representing 0.81% of the Company's share capital.

The Company acquires its treasury shares with the purpose to award shares to employees under the Award Programs.
