Hrvatska poštanska banka, p.l.c., Zagreb, Jurišićeva 4 (hereinafter: the Bank) in accordance with the Article 474 of the Capital Market Act, pursuant to the Notice on the Share Buyback Programme for HPB own shares commencing from January 19, 2022, until the next General Assembly of the Bank in 2022, hereby informs the investment community that it carried out following purchases of HPB own shares on the ZSE regulated market, as per the Share Buyback Programme:

- 101 shares labeled HPB have been purchased on January 21, 2022, at a weighted average price of HRK 797.52 per share, representing 0.004988% of the Bank's shareholder equity.

Following the purchases mentioned before, Bank has a total of 1,076 own shares, representing 0,053146% of the Bank's shareholder equity. Shareholder equity of the Bank amounts to HRK 1,214,775,000.00 and is divided into 2,024,625 common shares at face value of HRK 600.00 each.
