## **Subject: Notification of transactions of person discharging managerial responsibilities**

Pursuant to Article 19 of the Market Abuse Regulation (EU) No. 596/2014 of the European Parliament and the European Council and Commission Delegated Regulation (EU) 2016/522, and in line with Article 120 of the Zagreb Stock Exchange Rules, Croatian Telecom Inc. ("HT Inc." or "the Company") hereby notifies on the acquisition of Company shares by persons discharging managerial responsibilities.
