Within the Company's Share Award Plan (PDD) for the managers, on 12 May 2026 HT Inc. transferred 3,330 Company's shares outside the regulated market of Zagreb Stock Exchange (ZSE) to Members of the Management Board, in the value of EUR 40.34 per share, as follows:
