- Contract for the provision of supervision services of the construction of the Kašina-Zlatar Bistrica expressway, stage 1 from the Zlatar Bistrica Interchange to Marija Bistrica 3.5 km, estimated contract value in the amount of 694,559.28 euros, or total contract value (including VAT): 868,199.10 euros;
- Contract for the development of all types of conceptual design services with the obtaining of a location permit for the Varaždin-Ivanec-Krapina highway, section Lepoglava-Bednja-Đurmanec, approximately 17 km long, estimated contract value in the amount of 420,409.00 Eur, or total contract value (including VAT): 525,511.25 Eur.
