Zagreb, Janka Rakuše 1, OIB: 79766124714 (hereinafter: the Company) announces that on May 6th 2024., as part of a consortium led by the renowned Italian company Archest S.R.L., signed a framework agreement with Anas SpA in Italy for the provision of services for technical-administrative assistance services aimed at guaranteeing support to the RUP and the Works Management office for the execution of Scheduled Maintenance interventions - 16 LOTs.

The estimated value of the framework agreement is 5,000,000.00 EUR, of which 40% of the value, amounting to 2,000,000.00 EUR, is anticipated for the services provided by Institut IGH.
