## JGL Acquires Medicuspharma and Expands Its Portfolio of Generic Medicines in Croatia

Rijeka, 23 September 2025 – JGL d.d. has signed an agreement to acquire Medicuspharma d.o.o., a company specialized in the distribution of pharmaceutical and medical products. With this acquisition, the largest domestically owned pharmaceutical company in Croatia is creating a foundation for further expansion in the field of generic medicines and the hospital segment. In 2024, Medicuspharma generated total revenues of EUR 1.5 million and nearly EUR 300,000 in net profit.

Through this transaction, JGL is also strengthening its long-standing cooperation with Medochemie, a global manufacturer of generic medicines, whose hospital portfolio has so far not been included in JGL's offering. By integrating Medicuspharma's distribution agreements with Medochemie, JGL will significantly expand the availability of medicines in the Croatian hospital market.

"By acquiring Medicuspharma, we are opening new business opportunities in the hospital segment, further consolidating our position in the domestic generics market. We are confident that this acquisition will contribute to JGL's continued growth and development," said Dino Ćoza Saršon, Deputy Chair of the Management Board of JGL, adding that the value of the transaction will not be publicly disclosed.
