4. Changes in Voting Rights are the result of a transaction (sell) made through the Zagreb Stock Exchange (ZSE) on July 19, 2024, where the shareholders listed here under item 2., through a directly executed transaction (sell), sold their holdings of the Issuer's shares as follows:
- a) ERSTE PLAVI OBVEZNI MIROVINSKI FOND KATEGORIJE B, OIB: 37688683890; represented by Erste d.o.o., društvo za upravljanje obveznim i dobrovoljnim mirovinskim fondovima with its registered office in Zagreb, Ivana Lučića 2A, OIB: 49659289650, sold 5,400 shares of the Issuer marked KOEI, which represents 0.21% of the Issuer's share capital
- so that after the execution of the directly executed transaction (purchase) they hold the Issuer's shares as in item 2. here.
5. The shares, which previously exceeded 15% of the voting rights in the Issuer, have now fallen below the 15% threshold as a result of a sale on the ZSE

6. The number of shares/voting rights with which, on behalf of the shareholders' representative, for the account of the shareholders, has fallen below the 15% threshold, in absolute terms is 5,400 shares, and in relative terms, it represents 0.21% of the Issuer's share capital.
7. The total number of voting rights or shares, on behalf of the shareholders' representative, for the account of the shareholders ERSTE PLAVI OBVEZNI MIROVINSKI FOND KATEGORIJE B, in absolute terms is 381,660 shares, and in relative terms, it represents 14.84% of the Issuer's share capital, while the total number of voting rights or shares, in the name of the representative of the shareholders, on behalf of the shareholders of all the funds mentioned in item 2, in absolute terms, reaches 405,183, and in relative terms, this constitutes 15.75% of the Issuer's share capital.
8. The owner fell below the threshold prescribed by the Capital Market Law on July 19, 2024.
9. The Issuer's shares, marked KOEI, are held by the shareholder in accordance with Article 483, item 1 of the Capital Market Law - shares with voting rights of the issuer and do not have other voting rights referred to in Articles 484 and 485 of the Capital Market Law.
