
Management Board Report on the state of FTB TURIZAM d.d. for 2020

The operating results of FTB TURIZAM d.d. for 2020 show that the company is achieving its primary objectives.

In 2020, GOP (gross operating profit) was negative to the amount of c. 260,000 kn, while in the same period last year it was negative to the amount of c. 245,000 kn.

In 2020, according to the Usali report, the EBITDA (net profit + income tax + interest costs + amortisation + depreciation) for the FTB TURIZAM d.d. company was negative to the amount of c. 278,000 kn, while in the same period last year it was negative to the amount of c. 251,000 kn.


