on the conclusion of contractual documentation for acquiring shares in the company Conectart a.s., Czech Republic and Valoris Center S.R.L., Romania

The company BOSQAR d.d., Zagreb, (hereinafter referred to as the "Issuer", "Bosqar") hereby announces that on April 15, 2025, a subsidiary company in which the Issuer holds a majority of shares, M Plus Croatia d.o.o., Zagreb, entered into agreements regulating the terms and manner of acquiring more than 96% of the shares in the company Conectart a.s., Czech Republic ("Conectart") and 100% of the shares in the company Valoris Center S.R.L., Romania ("Valoris"). The remaining minority share in the company Concetart continues to be held by the management of the aforementioned company.

In relation to Conectart, the acquisition in question is not subject to any further third-party approvals, as a result of which, simultaneously with the signing of the transaction documentation, the company M Plus Croatia d.o.o., Zagreb, took over and acquired more than 96% of the shares in the company in question.

As for Valoris, the implementation of the transaction to acquire 100% of the shares in the company in question is conditional on obtaining approval from the competent regulators (including without limitation in the part relating to the protection of market competition), upon which all necessary activities will be carried out to transfer the shares in question in favor of the company M Plus Croatia d.o.o.
