ON THE CONCLUSION OF THE TRANSACTION CONCERNING THE CONCLUSION OF AN INVESTMENT AGREEMENT BETWEEN THE ISSUER'S SUBSIDIARY AND THE EUROPEAN BANK FOR RECONSTRUCTION AND DEVELOPMENT

Following the notice of the concluded Investment Agreement between the Issuer's subsidiary company, Meritus ulaganja d.d.
