Notification of the inclusion of Company BOSQAR d.d. into CROBEX, the flagship index of the Zagreb Stock Exchange

BOSQAR INVEST's share (BOSQAR d.d. - ZSE: BSQR) will be included in the CROBEX and CROBEXtr indices as of September 21, 2026, following the regular index review conducted by the Zagreb Stock Exchange Index Committee.

The change in index composition will be implemented after the close of trading on September 18, while the indices will begin to be calculated with their new composition on September 21. The review was conducted based on trading data for the period from March 1 to August 31, 2026.

CROBEX is the benchmark equity index of the Zagreb Stock Exchange, first published in September 1997. It is a price index comprising the most liquid stocks with the highest free-float market capitalisation, with the maximum weighting of an individual stock capped at 10 percent. In the new index composition, BOSQAR has been assigned a free-float factor of 45 percent, with 17,666,722 listed shares.

Joining the CROBEX marks a new stage in BOSQAR INVEST's development on the domestic capital market, where the company has been present since its listing on the Zagreb Stock Exchange in 2019.
