#### **Re: Acquisition of PODRAVKA Inc. shares**

PODRAVKA Inc., Ante Starčevića 32, Koprivnica, PIN: 18928523252 (the Company), hereby notifies that Milan Tadić, Member of the Management Board of the PODRAVKA Inc., based on realization of the Company share purchase option right, on June 9<sup>th</sup> 2023 purchased 2,500 ordinary shares of the Company at an average weighted price for the year 2019 of EUR 56.96 per share, which amounted to a total of EUR 142,400.00.

The shares' average daily price on June 9<sup>th</sup> 2023 was EUR 99.34, which makes the total of EUR 248,350.00 so the difference between the price at which the shares were purchased from the Company and the shares' average daily price is a total of EUR 105.950,00 which represents the basis for the calculation of tax benefits and determining the amount that belongs to Member of the Management Board of PODRAVKA Inc. Milan Tadić.
