The shares' average daily price on December 2<sup>nd</sup> 2022 was HRK 642.00, which makes the total of HRK 1,605,000.00, and shares' average daily price on December 5<sup>th</sup> 2022 was HRK 632.19, which makes the total of HRK 1,580,475.00 so the difference between the price at which the shares were purchased from the Company and the shares' average daily price is a total of HRK 1.424.725,00 which represents the basis for the calculation of tax benefits and determining the amount that belongs to Member of the Management Board of PODRAVKA Inc Davor Doko.


