The shares were acquired on August 10, 11 and 12, 2026, at organized market of the Zagreb Stock Exchange d.d., Zagreb.

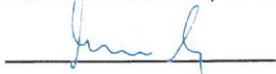

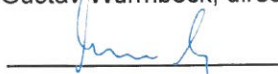
