The shares were acquired on September 9, 10 and 11, 2026, at organized market of the Zagreb Stock Exchange d.d., Zagreb.

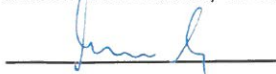

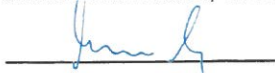
