Span signed a Share Purchase Agreement with the seller Fairway Limited liability company, Tallinn, Estonia for the purchase of 100% of shares in GT Tarkvara limited liability company, Tallinn, Estonia. The estimated value of the transaction is EUR 11.377.457,00 with the part of the purchase price subject to adjustment, depending on the business results of GT Tarkvara in 2023 and 2024. Span is acquiring a leading Estonian licensing and software asset management company with more than 25 years of experience. The latest Span acquisition is finalized only a year after the acquisition of Ekobit, a Croatian software company.
