Span d.d. released 1.207 of own shares based on the Share Buy-Back Programme for the purpose of offering Shares to employees of the Company and its affiliated companies for the purpose of remuneration, adopted at the Span d.d. Management Board meeting held on January 14th, 2022.

Prior to the said release, Span d.d owned 21.236 of own shares, representing 1.0835 % of the share capital. After the said release and as at the date of this Notice, Span d.d owns a total of 20.029 of own shares, representing 1.0219 % of the share capital.
