The acquisition in question was carried out pursuant to the Treasury Share Buyback Program of 25 May 2026, whereby the investment firm HITA-VRIJEDNOSNICE d.d., in the name and for the account of the Company, executed the following purchases of the Company's shares (treasury shares) on the regulated market of the Zagreb Stock Exchange.
