In accordance with Article 474 of the Capital Market Act, the Zagreb Stock Exchange, Inc. (hereinafter: the Company) with its registered office in Zagreb, Ivana Lučića 2a, VAT ID No. (OIB): 84368186611, hereby informs that, on the basis of the Own Shares Buy-Back Program¹, the company Privredna banka Zagreb, in the name and on behalf of the Company, made the following acquisition of the Company's shares (own shares) on the Regulated Market:

On 10 January 2023, 50 shares, ticker ZB, were acquired at a weighted average price of EUR 4.00 per share which represents 0.0022% of the Company's issued share capital.

The Company's issued share capital amounts to HRK 23,178,500.00 and is divided into 2,317,850 shares with a nominal value of HRK 10.00. Following the aforementioned acquisition, the Company holds a total of 5,582 own shares, which represents 0.2408% of the Company's issued share capital.
