**Subject: Notice according to Article 413 of the Capital Market Act**

According to the obligation from Article 413 of the Capital Market Act (NN 88/08, 146/08, 74/09) (hereinafter: ZTK) I herewith inform the issuer, AD Plastik d.d., and the Croatian Agency for Supervision of Financial Services as follows:


Based on the transactions concluded outside of the regulated market, i.e. MTP, which is managed by Zagrebačka burza d.d., on June 16, 2011, in the procedure of sale of 1,045,000 shares of the issuer AD Plastik d.d., organized by the investment company of FIMA-VRIJEDNOSNICE d.o.o. Varaždin, according to the order by lien creditors, ABANKE VIPA d.d. Ljubljana and NLB d.d. Ljubljana, **1,045,000 shares with voting rights of the issuer AD Plastik d.d.** Solin, stock exchange designation ADPL-R-A will be released on the date of the settlement, 20.06.2011 from the account of non-materialized securities of the company of Prevent Global d.d. – under bankruptcy, Slovenj Gradec, which is kept with Središnje klirinško depozitarno društvo d.d..

After the transactions performed on 16.06.2011, the company of Prevent Global d.d. – under bankruptcy, Slovenj Gradec, disposes over totally 36,770 shares with voting rights of the issuer AD Plastik d.d., which represents a portion of approximately 0.88% in the capital stock and the total voting rights with the issuer, calculated in line with Article 414 of ZTK, based on which the obligation of submitting this notice in the sense of the provision from Article 413 of ZTK has arisen.

This notice is submitted to the issuer with the instruction that the issuer is obliged to announce this notice to the public within three days from the day of its receipt.
