Pursuant to the Regulation (EU) No. 596/2014 on market abuse, Atlantic Grupa d.d., Zagreb, Miramarska 23 (hereinafter: the Company) hereby announces that Zoran Stanković, Member of the Management Board released 1.500 shares of Atlantic Grupa d.d., of the total nominal value of HRK 60.000,00, by the transaction made on the regulated market of the Zagreb Stock Exchange. Subject shares represent 0,04% of the share capital of the Company and provide 0,04% votes at the General Assembly of the Company.

Before the aforementioned release, Member of the Management Board Zoran Stanković held 4.524 shares of the Company, of the total nominal value of HRK 180.960,00, which represent 0,13% of the share capital of the Company and provide 0,13% votes at the General Assembly of the Company. After he aforementioned release, Member of the Management Board Zoran Stanković holds 3.024 shares of the Company, of the total nominal value of HRK 120.960,00, which represent 0,09% of the share capital of the Company and provide 0,09% votes at the General Assembly of the Company.
