Subject shares represent 0,007% of the share capital of the Company and provide 0,007% votes at the General Assembly of the Company.

Before the aforementioned release, Member of the Management Board Srećko Nakić held 6.219 shares of the Company, of the total nominal value of HRK 248,760.00 which represent 0,19% of the share capital of the Company and provide 0,19% votes at the General Assembly of the Company. After the aforementioned release, Member of the Management Board Srećko Nakić holds 5.969 shares of the Company, of the total nominal value of HRK 238,760.00, which represent 0,18% of the share capital of the Company and provide 0,18% votes at the General Assembly of the Company.
