(hereinafter referred to as: The Company) announces realization of the transfer of the treasury shares in accordance with the Option Program and the Remuneration Policy of Atlantic Grupa d.d. pursuant to which on December 11, 2017 the Company has transferred to the management and employees 404 shares of the Company with the total nominal amount of 16,160.00 kuna.

Before said transfer the Company had 2.153 treasury shares of a total nominal amount of 86,120.00 kuna, which represents 0.06% of the share capital of the Company. After said transfer the Company owns 1,749 treasury shares of a total nominal amount of 69,960.00 kuna, which represents 0.052% of the share capital of the Company.

Member of the the Management Board Mladen Veber was granted with 45 shares of Atlantic Grupa of a total nominal amount of 1,800.00 kuna, which represents 0.001% of the share capital of the Company. 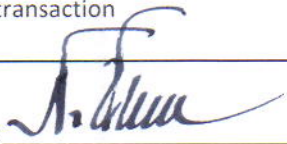
