## **Daniel Daub appointed for another term of office in the Management Board of Hrvatski Telekom; New composition of the Supervisory Board**

Hrvatski Telekom (Reuters: HT.ZA; Bloomberg: HTRA CZ), Croatia's leading telecommunications provider, announces that the Supervisory Board at its today's session appointed Daniel Daub as Member of the Management Board and Chief Financial Officer (CFO) for another 2-year term of office, commencing from 1 November 2020 when his current mandate expires.
